

#### OSHA Issues Safety Alert on Disposable Water Bottles



The Office of Environmental Health & Safety (OEHS) has issued a safety alert advising all staff not to reuse disposable water bottles (i.e. plastic) as doing so can pose a health risk. Reusing these bottles allows bacteria levels to multiply and the plastic to breakdown releasing chemicals into the contents. It is recommended to only use bottles that are specially designed for reuse,
